EXPERT OPINION REPORT

Referral Question:

Dr. Donna R. Milburn was commissioned as a testifying expert to render opinions regarding the nature of the relationship difficulties between the father and the minor child as of 2021. Dr. Milburn may also be designated to be available to testify as a rebuttal expert to any opinions offered by Ms. Frendle and by the child's play therapist and to the areas of psychology, treatment types, play therapy, parent-child relationships, parental alienation, child abuse, child custody evaluations, ethical guidelines and limitations of roles for professionals involved in family law litigation. Dr. Milburn will not be providing any recommendations regarding access and possession of this specific minor child with these parents. Dr. Milburn is not the child custody evaluator in this case.

General Summary Information and Clarifications regarding Expert Testimony:

Courts rely on information that they receive from mental health experts when they are making important decisions regarding child custody and child welfare issues. Texas laws have improved over the years to help the courts know what testimony should be given more weight and what testimony should be excluded or given less weight. The Texas Family Code has limited experts giving testimony about access and possession of children and conservatorship to a child custody evaluator and has set minimal guidelines for how that evaluation is to be conducted. The ethical guidelines of the professional and the Board Rules that govern the professional's license are additional requirements for behavior of professionals in these cases.

Attorneys representing the father Lauriston Crockett III in this case, have hired Dr. Donna R. Milburn as an expert to review information regarding the parent-child relationships and to render an opinion as to the factors contributing to the current relationship issues between the father and the child.

CONCLUSIONS REGARDING the FATHER – CHILD RELATIONSHIP:

The relationship between the father Lauriston Crockett III and the minor child appears to have deteriorated significantly. Information reviewed indicates that this deterioration is unlikely to be the result of a problem in the actual interactions between the father and the child as the father has been supervised in his access and he has had extremely limited time with the child. The most likely explanation for the deterioration is that the mother and stepfather have engaged in a pattern of behavior known as "Parental Alienation." The alienation of the child has been successful and has severely damaged the relationship between the father and the child.

The mother has engaged in parental alienation, prevented the child from having access to the father, testified in deposition that she does not want the father to have any contact with the child, and has testified that she wants the stepfather to adopt the child. The stepfather has engaged in parental alienation. The stepfather is heard on one video recording of the child coaching / encouraging the child to tell the staff member of the supervising agency statements negative about seeing the father where the child appears to have forgotten what he was taught to say prior to arriving and being filmed. The mother and stepfather have engaged in behaviors that resulted in the termination of supervision services. They have made apparent false reports of abuse against the father, have apparently failed to bring the child to visitation times as scheduled, and have engaged in a continuing pattern of behavior that has damaged the parent-child relationship between the father and the child.

BASIS FOR ABOVE CONCLUSIONS:

Dr. Milburn is a clinical psychologist who has extensive experience in forensic evaluations, child custody evaluations, psychological testing, neuropsychological testing, psychoeducational testing, ethical reviews of forensic cases for the Texas Board of Examiners of Psychologists, and providing direct treatment to children, adolescents, and adults. Dr. Milburn began providing forensic evaluations, testing, and recommendations to the courts over 31 years ago and has completed approximately 457 court evaluations to date.
